The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

I understand that the risk of becoming exposed to or infected by COVID-19 at 84-Sports may result from the actions, inactions, omissions, or negligence of myself and/or others, including, but not limited to, 84-Sports, its representative administrators, directors, officers, volunteers, employees, other participants, and owners of premises (each considered one of the "Releasee" herein) on which the Activity takes place.

I voluntarily agree to assume all of the forgoing risks and accept sole responsibility for any injury to my child (ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I or my child (ren) may experience or incur in connection with my child (ren)'s attendance at 84-Sports. On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless 84-Sports, its owner, instructors, employees, volunteers and representatives, and "releasees" named above and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of 84-Sports, its owner, instructors, employees, volunteers or representatives, and "releasees" whether a COVID-19 infection occurs before, during or after participation in any 84-Sports Activity/Visit.
